

SUMMARY ANNUAL REPORT FOR RENEWAL BY ANDERSEN EMPLOYEE BENEFITS PLAN

This is a summary of the annual report of the RENEWAL BY ANDERSEN EMPLOYEE BENEFITS PLAN, a health, life insurance, dental, vision, temporary disability and long-term disability plan (Employer Identification Number 81-4653145, Plan Number 501), for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

ESLER COMPANIES, LLC has committed itself to pay certain Dental, Health Flexible Spending Account and Wellness Program claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with CIGNA HEALTH AND LIFE INSURANCE COMPANY AND AFFILIATES (CIGNA), AMERICAN HERITAGE LIFE INSURANCE COMPANY, VISION SERVICE PLAN, PRINCIPAL LIFE INSURANCE COMPANY and AMERICAN HERITAGE LIFE INSURANCE COMPANY - ALLSTATE to pay certain Health, Vision, Life insurance, Temporary disability, Long-term disability, and other claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$14,573,134.
